# PRIVACY POLICY

This privacy policy for Combat Sales LLC ("Company," "we," "us," or "our"), describes how and why we might collect, store, use, and/or share ("process") your information when you use our services ("Services").

## 1. WHAT INFORMATION DO WE COLLECT?

# 1.1 Personal information you disclose to us
